

CAMPAIGN CONTRIBUTION LIMITS - 1-19.34.7 (D)

On the day after each general election, the contribution amounts provided in Subsection A of this section shall be increased by the percentage of the preceding two calendar year's increase of the consumer index for all urban consumers, United States city average for all items, published by the United States Department of Labor.

Therefore on November 9, 2016:

Contributions from a person to a candidate for non-statewide office remained as \$2,500.00

Contributions from a person to a candidate for statewide office; and from a person to a PAC increased from \$5,400.00 to \$5,500.00

Contributions from PAC to a candidate or from a PAC to a PAC increased from \$5,400.00 to \$5,500.00
