1 A MEMORIAL

2 RECOGNIZING THE NINETIETH ANNIVERSARY OF THE
3 LAS VEGAS-SAN MIGUEL CHAMBER OF COMMERCE AND INDUSTRY.

5 WHEREAS, the Las Vegas-San Miguel chamber of commerce

25 WHEREAS, the Las Vegas-San Miguel county chamber of


1 commerce and industry and its members strive to serve as a

11 development community;


12 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE
